MINUTES OF THE MEETING HELD ON TUESDAY, 1 NOVEMBER 2016, AT 7.30PM IN THE VILLAGE HALL, 108 LONDON ROAD, SHENLEY

59/16. Apologies for Absence.

Apologies for absence were submitted from Councillors Annette Edel, Peter Wayne and County Councillor Morris Bright.

60/16. Declarations of Interests

PERSONAL – Councillors Gilligan, Spencer and Susman declared a personal interest in the item concerning Shenley Park Trust.

61/15. Minutes of the Parish Council Meeting held on 6th October 2016

RESOLVED that the minutes of the Ordinary Parish Council meeting, held on 6th October 2016 be confirmed as a correct record, and signed by Cllr Susman and adopted by the Council.

63/16. Questions by residents of Shenley Parish

The Chairman welcomed Mr and Mrs Bury to the meeting. Mr Bury asked about the progress of the Black Lion development, as he was concerned that the old pub is now open to the elements as the windows have been removed. It was **AGREED** the Clerk would contact the developers and ask for a progress report.

Mrs Bury requested that Councillors Susman and Spencer bring up the issue concerning the inaccessible footpaths around Shenley Park at the next Park Trust meeting. They agreed to do so.

64/16. Shenley Parish Councillor Vacancy

The Chairman informed the meeting of the proceedings. Candidates were to be invited in one at a time to give a short presentation to the Council. Members of the public and the 5 candidates present were asked to leave meeting room whilst the candidates made their presentations. The candidates spoke in order of Helen Hussain, Simon Caplan, Norma Morgan, Matt Finn and David Saffer. The Chairman thanked the candidates for their presentations and informed them that the Clerk would contact them with the outcome on Wednesday 2nd November 2016.

Following the presentations the Councillors discussed the candidates and voted to Co-Opt Mrs Helen Hussain on as a Shenley Parish Councillor.

Shenley Parish Council would like to add that they are concerned with the restrictive access to the suggested homes, and the problems that may arise as a result of this.
